Eligibility Criteria: -

All erstwhile group 'D' employees, upgraded as Group 'C', ML-1 (erstwhile PB-I+GP 1800/-) and working in the following eligible category who have completed two year service in lower grade will be considered to appear in the Trade Test.

Further, IREM Vol.I, Para 214 (C) (i) provides that the condition of two years' service in

the immediate lower grade should stand fulfilled at the time of actual promotion and not necessarily at the stage of consideration.

The other eligibility Criteria for all Skilled Artisan-III, ML-2 categories is as under:-

- 1. P-Way side Khalasi/Works Khalasi

 - i) In case of adequate Number of P. Way Khalasi are either not available in the cadre or not willing for the post. Willing **Track Maintainer in P. Way Level-02 & Level-01** respectively can be considered on option basis.
 - ii) Where adequate numbers of willing P. Way Khalasi appears in the written test, but fails, the option to the track maintainer will open.
 - iii) Whenever an option is opened to track maintainer on the above lines, the written test will be conducted together for pay Level-02 &1 to save on time. The select list will be prepared in the order of Track Maintainer pay Level-02 followed by track maintainer pay level-01

Note: For the Track Maintainer Pay Level-2, movement to Artisan Gr-III will be considered as lateral induction; both being in the same level no benefit of Pay fixation will accrue. Pay fixation benefit will however be admissible to Track Maintainers Pay Level-1, being in a lower level than the Artisan Gr-III.

Having once joined as Artisan post the track maintainer will have to seek further promotion in artisan side only.

Mode of Selection:-The positive act of selection to assess the professional ability of the candidate shall consist of written test & record of Service only. The candidate has to obtain a minimum of 60% marks in professional ability, i.e. in written examination, for being considered for further selection process of perusal of Service Record.

Pre-Selection Coaching: - The above categories is -safety category, however there is no post reserved for SC/ST hence pre-selection coaching will not be

Date of Examination:- Date venue and time of Written Test Will be notified after finalization of panel against departmental quota. Candidates should be in readiness for the exam on short notice period. It is to be advised to the volunteering staff that there will be no supplementary examination to the absentees. This may be treated as advance notice for preparation for written test. In case of delay in issue of eligibility list or postponement of date of written test, no separate 3-4 weeks' time will be given.

Procedure for written examination:- The written examination consists of objective type questions with multiple choices. There will be negative marking for wrong answers for objective questions.

In terms of SPO (Ruling/Legal) CSMT's Lr. No. P/HQ/Ruling/O/803 dated 07.10.2022, Answer key of aforesaid selection will be published in the Rail net website for candidates who appeared in the written test to send representation, if any, with respect of keys and ambiguity in questions to this office The examinees (only candidates who appeared) will be given only 7 days (including intervening holidays) for sending written representation, if any. If any representation in this regard received the same will be forwarded to paper setting authority with relevant instructions issued by Rly Bd or HQ's Office for necessary action.

However, the decision of Paper Setting Authority will be final and no further correspondence in this regard will be entertained.

The final answer key with decision taken on representation received will be published within the period of 03 working days after completion of 7 days specified in above para. The decision taken on representation will also be intimated. Evaluation will be started only after the above exercise.

Procedure for drawl of Panel: - In terms of Rly Bd's L.No.E(NG)1.2008.P.M.7.4.SLP, dtd19.09.2009, the final panel shall be drawn in the order of merit based on aggregate marks of Professional ability and Record of service since. However, candidates must secure a minimum of 60% marks in the aggregate for being placed on the panel and final empanelment is subject to the availability of vacancies
